On behalf of myself, my personal representatives, heirs, next-of-kin, spouse and assigns,

I HEREBY:

1. Acknowledge that there is an inherent danger involved in being transported to and from various classes and in working with glass at various temperatures, and that attending Hot Glass Horizons 2008 involves risks that may cause personal injury or death.
2. Voluntarily assume the risk and danger of injury or death inherent in the use of the equipment and tools provided by Hot Glass Horizons 2008 and its instructors.
3.
